- Access to Services
- Accountability/ Fairness
- Learn from Mistake
- Stop Behavior
- School Safety
- Become successful students and happy people

Is Police Involvement/ Arrest the best way to Achieve those Goals?



What kinds of records are created from a police involvement?

- School record
- Arrest record
- Petition/ Charging Record
- Factual finding re: delinquent conduct (judge not jury)
 - Not Guilty
 - Dismissed
 - Guilty (after admission (plea) or adjudicatory hearing (trial))
- Adjudication of delinquency = Juvenile Record
 - Finding of delinquency + need for Treatment, Rehabilitation and Supervision by the Court
- Adult Records: Summary Citation, Summary Conviction

Juvenile adjudications are not criminal convictions..

But they are often treated that way

Juvenile Records NEVER automatically go away


Juvenile Arrests and Adjudication Limit Job Opportunities and Military Service

Civilians

- "Ban the Box" only applies to the first level of employment application
- Juvenile adjudications can affect professional licensing
- Even when employers only ask about convictions, juvenile adjudications may appear in a background check


Military

- The Army treats delinquency adjudications as criminal convictions
- Other branches of the military decide on a case by case base
- Military recruiters sometimes assist with getting juvenile records expunged





Families can lose public housingeven if the offense didn't happen there.





A juvenile adjudication for certain offenses, including possession of drugs, can result in deportation for non-citizens Driving Privileges will be suspended for 90 days to 1 year for

- Terroristic threats on school property or at a school activity
- Truancy
- Possession, sale or delivery of a controlled substance
- Purchasing, drinking or possessing alcoholic beverages
- Carrying false identification
- Racing or careless driving
- Driving to avoid arrest

Youth who are adjudicated (and even those who are diverted) have to pay court fees and sometimes restitution...



Juvenile adjudications are considered in adult sentencing - and can result in longer sentences



DNA is taken from ALL youth adjudicated of felony offensesand the DNA record is not destroyed even if the juvenile record is expunged



Juvenile adjudications do not prevent a person from voting or from serving on a jury

- To expunge a record, a motion must be filed with the court- usually by an attorney
- Records of adjudication can't be erased until FIVE YEARS after supervision has ended. DNA is never destroyed
- Many people think that juvenile records go away at 18 or 21- this is simply not true.



Expungement- No Quick Fix

When are cases eligible?

5 years- adjudicated delinquent or deferred adjudication
6 months after successful diversion
Immediately if found not guilty
BUT

Expungement is not automatic – it takes time and requires a motion to the court from a lawyer. By the time the request is considered, opportunities can be lost

In Pennsylvania, those records can affect access to education, employment prospects, occupational licensing, military enlistment, family housing, ability to receive a driver's license, public benefits, and credit, among other potential consequences. Youth must wait five years—often well into their 20s—to be eligible for expungement." P23

Recommendations

"Ensure that young people who have completed their obligations to the court are not held back from successful transition into adulthood by records of juvenile justice system involvement" p.39

Implementation requires legislation and/or rule changes (pending) and will require process development to track cases and ensure that records are truly expunged everywhere that they are located (including private background search companies) Recommendation 23: Create a standardized statewide expungement process We recommend that the Pennsylvania Rules of Juvenile Court Procedure and the Juvenile Act be amended to provide that the chief juvenile probation officer shall immediately notify the court and the court shall initiate the expungement process.

- Immediately upon dismissal or withdrawal of case
- Upon eligibility for expungement after successful diversion (6 months from completion)
- After two years have elapsed since the final discharge of the youth from supervision after a misdemeanor adjudication <u>if</u> no subsequent adjudications or convictions (or open cases) for a misdemeanor or felony

- Loitering
- Harassment
- Disorderly Conduct
- Littering
- Typical Sentence: Fines, sometimes community service. Not designed for treatment or services.,



A summary offense usually starts with a citation- which may seem like a traffic ticket



But is an ADULT CRIMINAL OFFENSE



Summary Trials

- No right to a lawyer
- Trial in absentia
- Right to Appeal (but no lawyer provided to request an appeal)
- Sent to Juvenile Court if doesn't comply with sentence/ pay fines

Most Frequent Alleged Offense Categories in PA Juvenile Courts 2020





Juvenile Summary Record

Unlike adult summary convictions, juvenile summary offenses are not open to the public



BUT

Juveniles must disclose summary convictions if asked on a job or college application



Expungement of Summary Citations

6 months after 18th birthday IF all conditions of sentence are completed

Expungement motion must be filed with the court

No one can see or use an expunged record



Automatic Sealing of Summary Convictions: Clean Slate Act

Summary convictions will be sealed after 10 years if the person has a clean record.

Sealing doesn't destroy the record- law enforcement can still see it.



Do Juvenile Arrests and Summary Citations Accomplish Our Goals for Youth?

Access to Services

- Can take months, if services are put in place at all
- Other avenues to services offer more consistency without stigma

Accountability/ Fairness

- Double punishment with school discipline:
- Justice system is slow

Learn from Mistake

• Restorative Justice and other EBP

Stop Negative Behavior in Schools

- Adolescent Brain Development- future punishment not best deterrent
- Arrested students return to schools
- Putting low risk youth into the justice system increases the likelihood of future delinquent behavior
